His first job out of college was a car salesman at Smith-Ford in Norwich and he then accepted a position as budget supervisor for the ethical medicine division of Norwich Pharmaceutical (then owned by Morton Salt).

He applied to and was accepted by Syracuse University Law School, graduating in December 1975, after 2-1/2 rather than the normal 3 years while working part time for a Syracuse law firm.

After a short time working in Cazenovia, Bill became an associate and then partner in the law firm of Stratton, Sullivan, Monaco & Smith. Subsequently W. Howard Sullivan and he were law partners until Howie's becoming Chenango County Judge in 2000. Since then, he practiced on his own and as partner with Frank Revoir until Frank's election as County Judge.

On November 1, 1985, Bill was appointed by Jim Haynes as assistant County attorney and continued in that capacity until December 30, 2014.

During his time in the County Attorney's office, he was assigned to answer all substantive; practical and procedural questions presented by the County Clerk. During that time neither his answers nor promptness in providing the same were ever questioned.

Bill's practice over the years has been focused on Real Estate and Estate matters. Very few, if any attorneys have had more dealings with not only the Chenango County Clerk's office but with County Clerk offices in the surrounding counties.

Many people do not understand what the County Clerk does, and all the detail and intricacies involved. This requires a person trained and experienced in the law. Bill has been a member of the Bar and licensed to practice law for over forty-four years and remains a member in good standing.
