<sup>\*</sup>Physical sciences include chemistry (inorganic chemistry, organic chemistry, and biochemistry), earth sciences (meteorology, astronomy, geology) and physics.\*\*Electronic sciences do not include coursework in electricity; electricity is a science that deals with the laws of electricity, while electronics is a branch of physics that deals with the emission, behavior and effects of electrons (in tubes and transistors) and with electronic devices.\*\*\*Mathematics includes coursework in accounting, economics, etc., provided primary focus of the course is manipulation of numbers.
